Other Terms and Conditions:

1. The position is purely on a contractual basis and may be extended on mutual consent and on the basis of satisfactory performance. The candidate engaged will have to execute an agreement with NMCG.
2. The candidate engaged shall have no vested right prior to and after the completion of the contract period for regularisation/absorption of his/her services in NMCG.
3. During the contract, the person will perform such duties as may be assigned to him/her in connection with the work of NMCG.
4. The selected candidates would have to execute a bond to serve for a minimum period of one year.
5. The NMCG reserves the right to fill or not to fill any position without assigning any reason.
